- Unaccompanied Foreign Minors (MENA) - Reception Guide: Pre-school, Primary and Secondary Education


- They all have the opportunity and the resources to learn the Portuguese language;

## EDUCATION AND MIGRANTS

### **GROWING TOGETHER**

The 'Growing Together: Immigrants Empowerment as Local Citizens and as Educators project' project involves a partnership of three municipalities and three schools that share similar characteristics relating to territory and population.

They share some challenges related to ensuring quality services and development conditions for the population and territory, on equal terms for all and without discrimination.

One of these shared realities, and which motivated this partnership, is the integration and well-being of immigrants. -

This project is aimed at adult immigrants with children in schools from S. Teotónio (Odemira, Portugal), Lleida (Spain) and Follonica (Italy).

It aims to contribute to the well-being and integration of immigrants and to the promotion of a society with intercultural dynamics, by recurring to early intervention in academic and social integration of the young children of immigrants (therefore with the 2nd generation).

The project thus aims to relate two factors: the participation of immigrants, as parents, in their children's school education; and the participation of immigrants in society.

The project has defined actions, such as workshops for school professionals and workshops for immigrant adults, also including moments of citizenship, to be carried out in the 3 countries, with the aim that they have an impact on the daily lives of immigrants, covering the various dimensions of your life.

The project lasted 2 years (starting in October 2016 and ending in September 2018).

#### **APAV**

UAVM is the Migrant Victim Support Unit created by the Portuguese Victim Support Association (APAV)

It appears that immigrant victims of crime and victims of discrimination in general lack specialized support.

It emerged to address the problems of these target audiences.

- information about rights and how to exercise them
- psychological, emotional and social support
- Confidential and free of charge, and in a safe and exempt location.

### **RUMO**

Rumo was founded in 2016, at the Annual Forum of Portuguese Graduates Abroad, and has been providing online psychology services.

Composed of a specialized team recognized by universities and professional entities,

Multidisciplinary approach focused on responding to the different difficulties of the immigrant population.

## PORTUGUESE LAW AND MIGRANTS

Relevant International and European legislation applicable in Portugal regarding refugees and migrants:

·UDHR (1948) - in Portugal since 1976: article 14 - "Everyone has the right to seek and to enjoy in other countries asylum from persecution" Refugee Convention (1951) - DL - 43201, 1st October 1960

oCore principles: non-refoulement; right to housing, work and education while displaced ·1954 Convention relating to the Status of Stateless Persons - Decreto do Presidente da República n.º 134/2012, de 7 de Agosto: ratificação •ECHR – December 1978

The Portuguese legislation regarding refugees is relies on the Portuguese Constitution, that assures right of asylum to foreign and stateless people being pursued or under real and effective threat of pursue.

Law No. 27/2008, of June 30, establishes the conditions and procedures for granting asylum or subsidiary protection and the statuses of asylum seeke and refuge.

In Portugal, a refugee is a foreigner who is outside his or her country of nationality or habitual residence, and who cannot or does not wish to return to that country for a well-founded fear of persecution on the grounds of race, religion, nationality, social group or political opinion, or for reasons of belonging to a particular group or a particular category.

An asylum seeker is a foreigner who requests recognition of the refugee status.

Therefore, A foreigner who does not meet the requirements to be considered a refugee may be recognized as a beneficiary of subsidiary protection if he or she is at risk of suffering serious violations of his or her fundamental rights in the event of return to his or her country of origin or habitual residence.

The granting of refugee or subsidiary protection status gives the beneficiary the right to remain in Portugal, to obtain a residence permit, to access employment, education, health care, and other social services.

Summary of the rights of refugees in Portugal:

- Right to remain in Portugal;
- Right to obtain a residence permit;
- Right to access employment;
- Right to access education;
- Right to access health care;
- Right to other social services;
- Right to a fair and expeditious asylum process;
- Right to free legal assistance.




